- **Pupil support -** responsible for behaviour, safeguarding, attendance, children's spiritual moral social and cultural development, children, parent and staff voice, extra-curricular activities, cluster and other partnerships. **Committee chair Chantel Johnson**
- Pay Review committee responsible for ensuring the implementation of the school Pay Policy and Teacher Appraisal Policy.
- Pay Appeal committee responsible for hearing pay appeals and ensuring a fair and proper process has been followed.
