I spent the best part of the afternoon in Mrs Sheerin's office preparing cards with tickets on for one of the stalls. During this time, various members of staff came into the room not expecting to see me there, and, I could hear the voices of others as they passed by in the corridor undertaking various preparatory tasks of their own. The atmosphere was upbeat, co-operative and supportive. At no time did I hear a moan or a complaint. This carried through to setting up of the stalls and engaging with parents and children. Even when there was a sudden leak in the disabled toilet which sent a lake of water flooding into Windermere just before the door opened, this was dealt with in a calm manner with many hands on deck. The fair was a joyful community event.
- 2. Great care was taken in the setting up of stalls, attention being paid to detail, and the stalls looked beautiful. This is a continuation of the care and commitment to high standards that informs everything the school does, showing pride and respect on behalf of the staff to the children, parents and community the school serves.
- 3. The event was well attended and there was a happy throng of parents/carers, children and members of the wider community. Some parents turned down their change demonstrating their support of the school, and the children practised and used their good manners when asking to buy something and accepting their change.
